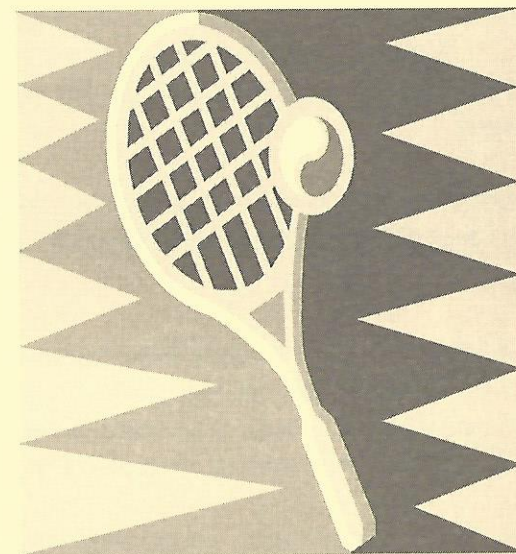

2. Deposits are refundable on cancellation only if the CRC is able to resell the court for the season.
3. Payment must be made in full by October 20. Coordinator is responsible for full payment of court.
4. CRC reserves the right to put the group on any available court for the season.
5. The group will be responsible for any applicable federal, state or local taxes that might be levied against those fees during the course of the season. This will include any taxes that are levied retroactively. Current fees do not include any such tax.
6. Court reservation will only be held with full deposit.
7. CRC is not responsible for any lost or stolen personal property left in the facility.
8. All players, including guests, are strictly at their own risk. CRC is not responsible for any injuries, accidents or damage to personal property arising from normal athletic activity at this facility.
9. There will be no make-up dates offered for any missed time due to personal reasons.
10. Any group that the CRC deems undesirable can be expelled and season time will be prorated.
11. No rebate, credit or make-up time shall be due for loss of court time due to circumstances beyond CRC's controls (acts of God.)
12. CRC reserves the right to change all or part of this offering for unsold or unreserved time without prior notice.

Dear Tennis Player:

Reservations for 2018-2019 season court time rentals are now being accepted. With each court hour to be reserved, a \$400 per hour non-refundable deposit must be paid (\$600 for one and a half hours.) The current 2017-2018 season court rentals will have priority for next season until April 10, 2018.

After April 10th, court time reservations will be processed on a first-come, first-served basis. Each application must be accompanied by a deposit or it will not be accepted.

Any seasonal reservations that are paid in full by August 25, 2018 will receive a 5% discount.

Full payment for each court time reservation is due by October 20, 2018. Any court time that is not paid in full by this date is subject to a 1% monthly interest or loss of court.
